PROPOSED ADJUSTMENT TO THE INVESTMENT BUSINESS PLAN FOR THE YEAR 2023

The Board resolved to adjust the investment business plan of the Company for the year 2023 on 5 December 2023, subject to the approval of the Shareholders at the EGM by way of an ordinary resolution.

The proposed adjustment to the investment business plan of the Company for the year 2023 was made in accordance with the actual progress of project development and construction. The total amount of the original plan was RMB11.95 billion and was increased by approximately RMB864 million to RMB12.814 billion. The investment business plan is divided into the fixed asset investments plan and the equity investments plan. The total amount of the fixed asset investments plan was increased by approximately RMB96 million as compared to the original plan, while the total amount of the equity investments plan was increased by approximately RMB96 million as compared to the original plan, while the total amount of the equity investments plan was increased by approximately RMB767 million. These adjustments were made to better monitor and manage the progress of investment projects and to achieve annual investment targets of the Company.
